Minutes of the 99th Meeting of the NLCPR Committee held at 1500 Hrs on 20.09.2011 under the Chairmanship of Secretary, M/o DoNER in Committee Room No.243, Vigyan Bhavan Annexe New Delhi.

After presentation by the representative of Government of Assam, the Committee deliberated on the Agenda items. Following observations and recommendations were made by the Committee:

Item No.1: Confirmation of the Minutes of 98th Meeting of the NLCPR Committee held on 25.08.2011

The minutes of 98th Meeting of the NLCPR Committee issued on 06.09.2011 were confirmed.

Item No.2: Action taken report of decisions / recommendations made by NLCPR Committee in the 98th Meeting held on 25.08.2011.

The Committee noted that the minutes of the 98th Meeting of the NLCPR Committee are issued on 06.09.2011 and the actions on the recommendations made by the Committee are being taken.

Item No.3: Priority List for 2011-12 of Assam

After Presentation, the Committee deliberated upon the Priority List submitted by the Government of Assam in accordance with Para 4.1 of the Revised NLCPR Guidelines.

After deliberations, the Committee recommended retention of following 10 Projects with estimated cost of Rs. 23143.54 lacs:

Item No.4: Project – “Tamulpur Piped Water Supply Scheme” in Assam.

The Committee noted that the DPR of the project has been vetted by the Department of Drinking Water Supply (D/o DWS), Ministry of Rural Development at a cost of Rs. 299.45 lacs.

2. After detailed deliberations and keeping in view the 'Justification Note' submitted by the State Government, the Committee recommended sanction of the project at a cost of Rs. 293.70 lacs (including 1% Contingency charges amounting to Rs. 2.91 lacs) with the conditions stipulated by the D/o DWS. However, the contingent expenditure would not include any work charged establishment, daily wage charges or any other staff charges. The details are as under:

3. The Project has been recommended for sanction with the following conditions:

- i. The State Government / Implementing Department will comply with the following observations made by the D/o DWS, M/o RD
 - a. Since it is proposed to have all house – hold with house – connection meter should be provided and tariff should be collected to achieve at least 50% cost of O&M since in total HP of the pumps provided is 30 as such cost of electricity may work out to be quite high.
 - b. Source sustainability should be incorporated in the project proposal
 - c. Training and Capacity building of VSSCs should be incorporated

- ii. The Contingency charges may be reimbursed on submission of document on actual contingency expenditure excluding cost of establishment, audit and accounts, O&M, departmental charges, quality control, agency and purchase of vehicle.
- iii. Transparency should be maintained in tendering process and the State Government should ensure that the tender has been called on competitive basis by giving wide publicity in print media and website etc. and the works have been awarded within 3 months of its sanction, even without waiting for the release of funds from State Government to Implementing Agency.
- iv. The State Government should follow all codal formalities and strictly adhere to the project implementation schedule and physical targets given in the DPR.
- v. The project implementation by the State Government will be governed by the rules / conditions stipulated in the revised guidelines of NLCPR.
- vi. A non- duplication certificate may be obtained from the State Planning Department before issue of sanction.

Item No.5: Project – “Construction of RCC Br. No. 8/1 over Saral Bhanga on Dotma Balajan Road” in Assam.

The Committee noted that the DPR of the project has been vetted by the Ministry of Road Transport & Highways (M/o RT&H) at a cost of Rs. 1226.12 lacs.

2. After deliberations, the Committee recommended sanction of the project at a cost of Rs. 1202.31 lacs (including 1% Contingency charges of Rs. 11.90 lacs) after deducting 1% Quality Control and 1% Labour Cess. However, the contingent expenditure would not include any work charged establishment, daily wage charges or any other staff charges. The details are as under:

- i. The State Government / Implementing Department will comply with the observations made by the M/o RT&H (**Annexure-II**).
- ii. The Contingency charges may be reimbursed on submission of document on actual contingency expenditure excluding cost of establishment, audit and accounts, O&M, departmental charges, quality control, agency and purchase of vehicle.
- iii. Transparency should be maintained in tendering process and the State Government should ensure that the tender has been called on competitive basis by giving wide publicity in print media and website etc. and the works have been awarded within 3 months of its sanction, even without waiting for the release of funds from State Government to Implementing Agency.
- iv. The State Government should follow all codal formalities and strictly adhere to the project implementation schedule and physical targets given in the DPR.
- v. The project implementation by the State Government will be governed by the rules / conditions stipulated in the revised guidelines of NLCPR.
- vi. A non- duplicacy certificate may be obtained from the State Planning Department before issue of sanction.

Item No.6: Project, Augmentation of Water Supply Scheme at Kamjong in Ukhrul (0.22 MLD), Manipur.

The committee noted that the project was retained at Rs.5.25 crore in its 65th Meeting held on 16.02.2009. The Committee also noted that the D/o Drinking Water Supply recommended the proposal at Rs.524.82 lac.

2. After deliberations, the Committee recommended the project for sanction at a cost of Rs.525.82 lac, including 2% contingencies with the following components and conditions:

Item No.7: Project, Augmentation of Water Supply Scheme at Nunghar and adjoining 4 (four) villages in Ukhrol (0.40 MLD), Manipur.

The committee noted that the project was retained at Rs.6.51 crore in its 65th Meeting held on 16.02.2009. The Committee also noted that the D/o Drinking Water Supply recommended the proposal at Rs.544.06 lac.

2. After deliberations, the Committee recommended the project for sanction at a cost of Rs.544.06 lac, including 2% contingencies with the following components and conditions:

Item No.8: Project, Augmentation of Water Supply Scheme at Tolloi in Ukhrul (0.27 MLD), Manipur.

The committee noted that the project was retained at an estimated cost of Rs.3.46 crore on recommendation of NLCPR Committee in its 65th Meeting held on 16.02.2009. The Committee also noted that the D/o Drinking Water Supply recommended the proposal at Rs.322.93 lac.

2. After deliberations, the Committee recommended the project for sanction at a cost of Rs.322.93 lac, including 2% contingencies with the following components and conditions:

Item No.9: Project, Modernization of electrical network in and around Melli Bazaar, South Sikkim under NLCPR – for consideration of sanction

The Committee noted that the project was retained at an estimated cost of Rs.10.40 crore from the priority list 2010-11 of Government of Sikkim in its 80th Meeting held on 08.04.2010. The Central Electricity Authority (CEA) recommended the project for sanction at Rs.1068.54 lacs. After deliberations the Committee recommended the project for sanction at Rs. 885.96 lac with following components and conditions.

Conditions:

- The contingency charges may be reimbursed against the actual contingent expenditure on production of documentary evidence. But it shall not include expenditure on Work Charge Establishment.
- State Implementing Agency should follow all codal formalities while executing the project.
- Codal formalities should include tenders being called on competitive basis by giving wide publicity in print media like Newspapers & Trade Journals and web based publicity.
- The construction agency may adhere to the time schedule given by them in the estimate for completion of the project.
- Justification for provision of 10% Transportation may be sought from the State Government.

Item No.10: Rabindra Convention Centre (Satabarshiki Bhavan) in Tripura for consideration of sanction

The Committee observed that the project was retained for detailed examination from the Priority List 2008-09 of Tripura in its 60th Meeting held on 18.07.2008 at Rs.19.00 crore.

The MoUD vetted the DPR with Rs.2363.90 lac with the conditions that the project may consider for funding under NLCPR scheme only after getting no objection certificate from the Ministry of Culture since the project was also proposed to M/o Culture by the State

Government. The Ministry of Culture vide letter No.16-2/2010-Spl.Cell/P.Arts dated 26.08.2011 addressed to State Government and copy endorsed to M/o Diner informed that they have noted the decision of the State Government to withdraw the proposal and would have no objection if the said proposal is considered for funding by the Ministry of DoNER under its NLCPR scheme.

After deliberations, Committee recommended the project for sanction at Rs. 2194.21 lac with following components and conditions.

Conditions:

- a) The 2% contingency charges may be reimbursed against the actual contingent expenditure on production of documentary evidence but shall not include expenditure on Work Charge Establishment.
- b) Transparency should be maintained in tendering process and the State Government should ensure that the tender has been called on competitive basis by giving wide publicity in print media and website etc. and the works have been awarded within 3 months of its sanction, even without waiting for the release of funds from state government to implementing agency.
- c) The state government should follow all codal formalities and strictly adhere to the project implementation schedule and physical targets given in the DPR.
- d) The project implementation by the state government will be governed by the rules/conditions stipulated in the guidelines of NLCPR.
- e) The implementing agency may be encouraged to use energy efficient devices and equipments as per guidelines of Bureau of Efficiency (BBE), Govt. of India who have developed "Manual for development of Municipal Energy Efficiency Projects" and may take their consultation in this regard.
- f) The implementing agency should ensure that the project as a whole is disaster resilient and necessary measure will be taken to make it fully disaster resistant and DM audit shall be got conducted on completion of the project.
- g) Proper structural design for the related structural components shall be got done and proof checked by structural consultant of repute before actual execution of the work.
- h) Proper geotechnical investigation for all related geotechnical components shall be got done and proof checked by geotechnical expert of repute before actual execution of the work.
- i) The formalities relating land acquisition etc. if any may be completed before taking up the work.
- j) Implementing Agency shall follow the proper and approved administrative, financial and technical procedures for execution of the work at competitive cost.
- k) The execution of the project shall be strictly on competitive rate basis.
- l) Implementing agency shall obtain all necessary permission/Clearances from concerned authorities prior to commencement of works.
- m) The work shall be executed by the implementing agency as per relevant codes and specifications as applicable.
- n) The implementing schedule should be strictly adhered to in order to avoid any time and cost overrun.

- o) The Administrative and Financial approval may be issued after receipt of non-duplication certificate from the State Government.

Item No.11: Proposal of "Widening & strengthening of Jolaibari-Kowaifung road (11.70 Km)' in Tripura under Non-Lapsable Central Pool of Resources (NLCPR).

The Committee noted that the project was retained for 'Widening & Strengthening of Jolaibari - Kowaifung - Ailmara Road (22.00 km)' in the 32nd meeting of NLCPR Committee held on 28.02.2005 from the Priority List 2005-06 of Tripura at an estimated cost of Rs.10.70 Crore. The State Government submitted DPR for "Widening & Strengthening of Jolaibari-Kowaifung" (11.70 Km) section of the road at Rs.8.90 crore, as the balance "Kowaifung to Ailmara" (9.50 Km) section of road was sanctioned by the North Eastern Council (NEC) at Rs.313.75 lac only (Rs.33.03 lac/Km) in March 2005. The DPRs of Jolaibari-Kowaifung" (11.70 Km) were examined in Department of Road Transport (DoRTH). The DoRTH observed that, the existing road is already having single lane carriageway and formation, its widening to 5.50 carriageway and 9.0 m formation as proposed, is not justified in view of the extremely low traffic volume. The Committee also noted the variation of specifications and per unit cost in the proposal sanctioned by NEC and that proposed under NLCPR.

After deliberations, the Committee recommended that, in view of the large variation in the scope and cost at which it was retained, the variation in the cost and scope of components in the part of road sanctioned by NEC and the part proposed under NLCPR and also time lag from its retention, it will not be appropriate to sanction the proposal in the present form and may be deleted from the list of retained projects. The State Government may be asked to review the proposal and if it is still relevant then consider proposing a fresh in next Priority List.
