No. HADP/2018-19/(Tml/Noney)/124/Plg: The Governor of Manipur is pleased to constitute a State Level Sanctioning Committee (SLSC) in compliance of the new Guidelines for Hill Area Development Programme (HADP) in the North East circulated by the Ministry of Development of North Eastern Region (DoNER), Govt of India vide No. EandP-12/6/2017-0/oEA dated the 17th May, 2018 to streamline the process of sanctioning of Detailed Project Reports for HADP in Tamenglong District including Noney (pre-revised district delineation) under the Ministry of Development of North Eastern Region, Govt of India.

2. The State Level Sanctioning Committee (SLSC) shall comprise of the following members:

3. The chairman may co-opt/invite officials from reputed State level institutions such as National Institute of Technology (NIT)/ Central Agricultural University (CAU) for techno-economic feasibility of the Detailed Project Reports (DPRs) and providing its recommendations.

4. The functions of the Sanctioning Committee are:

- a) To verify availability of necessary regulatory / statutory clearances *inter alia* Forest & Environment, Non-encumbrance free land, Non-Duplication Certificate and Stone quarry.



- b) To identify / finalize the shelf of projects and designated agency for execution of projects based on the recommendations of the District Level Committee.
 - c) To ensure proper implementation and monitoring of each project sanctioned.
 - d) To examine the techno-economic aspects of the DPR prepared, and recommend its sanction/ non-sanction. The cost escalation while finally recommending the project will be allowed to the extent of 10%-15% over the retained cost.
 - e) To ensure earmarking of adequate budget (not less than 25%) for schemes beneficial to women and child.
 - f) To take any other decision for the smooth implementation of the HADP or any other project under the Ministry of Development of North Eastern Region, Govt of India.
5. Planning Department shall be the administrative department for HADP in Tamenglong District including Noney (pre-revised district delineation) under the Ministry of DoNER, Govt of India.
6. The Committee shall meet as and when required.

- d) To oversee the implementation of the schemes.
